It outlines the beliefs and values that underpin learning and teaching in our schools.

The Learning and Teaching framework aligns with and is informed by:

The Alice Springs (Mparntwe - pronounced as 'M-ban-tua') Education Declaration released in December 2019, sets the national vision and goals for education for all Australians, agreed on by all education ministers in Australia. It replaces the Melbourne Declaration.

The Mparntwe Declaration outlines two goals similar to the 2008 Melbourne Declaration:

- The Australian education system promotes excellence and equity.
- All young Australians become confident and creative individuals, successful lifelong learners, and active and informed members of the community.
- The Melbourne Declaration, now the Alice Springs (Mparntwe) Declaration (2019); Key changes
- Queensland Catholic Schools and Curriculum, 2021 and the key assertions that: our focus is
  on the whole person; learning and living are inextricably linked with living life to the
  full, and; learning and teaching prepare students for global responsibilities and to work for
  the common good;
- Visible Learning (Hattie, 2009) evidence base on the factors that impact positively on student achievement.

The overarching goal for learning in Brisbane Catholic Education schools is to empower learners of all ages to shape and enrich our changing world, by living the Gospel of Jesus Christ. All phases of schooling are informed through Brisbane Catholic Education's **Learning Framework; Strategic Renewal Framework; Religion Curriculum; Queensland Studies Authority** publications; the **Australian Curriculum** and government regulatory compliance requirements.

The Religion Curriculum P-12 and materials are the source for all planning of Religious Education in Brisbane Catholic Education Schools.

The Australian Curriculum currently under review is the source of all curriculum planning, assessment and reporting for all Learning Areas covered by the Australian Curriculum.
